In April, the PhillyLabor Injured Workers Advocacy Program announced the induction of Gross into the Legends of Justice Hall of Fame—an honor recognizing Gross's unwavering commitment to representing injured workers throughout his distinguished career. Kenny, who is certified as a specialist in the practice of workers' compensation law, has been recognized as a Super Lawyer and previously as a Super Lawyers Rising Star.

Jeffrey Gross is currently the Chair of the Pennsylvania Bar Association Section on Workers' Compensation Law. All attorneys at Gross & Kenny LLP are members of the Pennsylvania Association for Justice, and are members of Philadelphia Trial Lawyers Association. Gross has served on the Philadelphia Bar Association executive committee since 1999, and is a past chair of the Philadelphia Bar Association's Workers' Compensation Section. He is on the board of directors of both the Philadelphia Trial Lawyers Association and the Pennsylvania Association for Justice, and also serves on the board of Kids' Chance of Pennsylvania, which supports individuals needing assistance for college or vocational education due to a parent having been killed or injured catastrophically at work.

Considering the long-term implications of a work-related injury, workers need to have the utmost confidence in the firm they hire to represent them. They also need to understand how much the representation of a skilled workers' compensation attorney will cost.

"We do not charge an hourly rate for representation," Gross says. "Our fee is limited to 20 percent of our recovery for our clients. We don't get paid unless we win the case and unless it's approved by a judge. The real question to me is: How can you afford *not* to be represented by a lawyer from our firm? We don't get paid unless we get our clients paid."

Gross & Kenny LLP welcomes referrals from other law firms who require the expertise of attorneys who specialize in workers' compensation claims. Not only will Gross & Kenny pay a referral fee to the firm, but it will also keep the firm fully apprised on the status of the case.

Between them, Gross and Kenny have decades of experience answering questions that are specific to a client's case and then taking the case forward. In the end, after they have delivered a favorable outcome for a client, the attorneys' reward isn't so much what the client says, but the subtle gestures of appreciation they offer.

"I once represented a client from Algeria who was a U.S. citizen," Gross recalls. "He was so happy we won his case that when he went back to Algeria to visit his family, he sent me a heavy wooden statue with many different symbols on it designed to ward off evil. That was special to me."

"Our goal is to exceed our clients' expectations," he continues. "The look we get from a client when we help them with a settlement that maybe they didn't expect to win is one of the greatest moments in life. There's a term for when you have a low expectation, but end up achieving something significant. It's called happiness." ■
