Carosella also ran a plumbing, heating, and air conditioning enterprise he purchased to “keep me occupied” while going through law school. Some of the most important lessons learned along the

way came from a business attorney who became an invaluable mentor. Now he’s happy to do the same for his clients.

“I like it when an individual comes in here with an urge to grow their business but they don’t know how,” he says. “I know how to do it, because I’ve lived it. The commodity may differ from one business to another, but the principles of every business are almost always the same.”
